

MONONA COUNTY ORDINANCE 38

WHEREAS, Resolution 2011-30 has been adopted setting the Supervisor Districts necessitating changes in the voting precincts; and,

WHEREAS, each County Board of Supervisors shall make any changes in precinct boundaries in the year immediately following each year in which the federal decennial census is taken in order to comply with Iowa Code;

NOW, THEREFORE BE IT HEREBY ORDAINED by the Monona County Board of Supervisors that the following precincts and boundaries of each are hereby established:

- 1- All of the area included within the boundaries of Ashton, Belvidere, Lincoln, and Kennebec townships excluding the cities of Whiting and Castana, and the area in Franklin Township lying north and west of the following line beginning at Dogwood Avenue and Highway K42: Dogwood Avenue south to Dogwood Loop, Dogwood Loop south to Dogwood Avenue, Dogwood Avenue south to Highway 175, Highway 175 west to Cypress Avenue, Cypress Avenue south to the end of Cypress Avenue, the end of Cypress Avenue south west following census block GEOID 191339602001258 to the Franklin Township Line, and the area in Franklin Township lying south and west of census block GEOID 191339602001258, and the area in Franklin Township lying north and east of 240th Street and Highway K45 outside of the corporate limits of the city of Onawa.

- 4- All of the area included within the boundaries of Fairview, Lake, West Fork, and Grant townships including the corporate limits of the cities of Rodney and Whiting.
- 5- All of the area included within the boundaries of Spring Valley, Soldier, and Willow townships including the corporate limits of the cities of Moorhead and Soldier.
- 6- All of the area included within the boundaries of Onawa Ward Two (2) and the area in Franklin Township lying within the following boundary excluding census block GEOID 191339603003008 and census block GEOID 191339602001282: Beginning Point One (1): Highway K42 at the north west corporate limits of the City of Onawa: Highway K42 west to Dogwood Avenue, Dogwood Avenue south to Dogwood Loop, Dogwood Loop South to Dogwood Avenue, Dogwood Avenue south to Highway 175, Highway 175 west to Cypress Avenue, Cypress Avenue south to the end of Cypress Avenue, the end of Cypress Avenue south west following census block GEOID 191339602001258 to the Franklin Township Line and Beginning Point Two (2): Highway K45 at the south corporate limits of the City of Onawa: Highway K45 south to Hemlock Avenue, Hemlock Avenue south to 260th Street, 260th Street west to Filbert Avenue, Filbert

Avenue south to the end of Filbert Avenue, the end of Filbert Avenue south west following census block GEOID 191339602001258 to the Franklin Township Line.
